

• INTRODUCTION •

Pursuant to and for the purposes of the GDPR - General Regulation on Data Protection (EU) 2016/679, Sweetbio Srl through this form - also available on our website www.sweetbio.it - intends to provide, as provided herein, the information required by Articles 12 and 13, in a concise, transparent, intelligible form and with a simple and clear language, to the interested party, that is to the physical person to whom the personal data refers: individual entrepreneur, trader, artisan, professional, consumer, etc., or who acts in the name and on behalf of legal persons as their director, attorney, executive, partner, auditor, guarantor, etc., in his/her capacity - depending on the case - of client and / or supplier and, in order to obtain his free, specific, informed and unequivocal consent, as defined by Art. 4 and provided for by Art. 7, to the lawful processing of personal data, necessary and finalized to the execution of a contract of sale (with the customer) or supply contract (with the supplier) of which the interested party is part or to the execution of pre-contractual measures taken on request of the same .

The GDPR gives - among others - the following definitions:

- 'Personal data' means any information concerning an identified or identifiable (interested) physical person;
- 'Processing' means any operation or set of operations performed with or without the aid of automated processes and applied to personal data or sets of personal data, such as the collection, registration, organization, structuring, storage, 'adaptation or modification, extraction, consultation, use, communication by transmission, dissemination or any other form of making available, comparison or interconnection, limitation, cancellation or destruction;
- 'Special categories of personal data' means those which reveal racial or ethnic origin, political opinions, religious or philosophical convictions, or trade union membership, as well as those relating to genetic or biometric data intended to uniquely identify a person physical, data relating to the health or sex life or sexual orientation of the person.

The data controller has not been designated, as there are no reasons for such provisions.

C) IDENTITY AND CONTACT INFO OF THE DATA PROTECTION OFFICER

The data protection officer has not been designated, as there are no reasons for such provisions.

D) PURPOSE AND LEGAL BASIS OF THE PROCESSING TO WHICH THE PERSONAL DATA ARE INTENDED

The personal data of the interested party , in his / her capacity - depending on the case - of customer or supplier, as defined in the Introduction, are processed within the following activities of Sweetbio Srl , to be exercised also through participation in other companies: production, import, export and commercialization, both in retail and wholesale, and in any form, of food products and of organic products in general, and of products similar and complementary to the food sector; hiring of both national and international representations; technical/ analytical consultancy aimed at ascertaining the "conformity" of food products, for purposes related to the execution of a sales contract (with the customer) or supply contract (with the supplier) of which the interested is a part or execution of pre-contractual measures taken at the request of the same, namely:

- 1) purposes connected to an obligation established by law, by a regulation or by community legislation, as well as by provisions of authorities authorized to do so and by supervisory and control bodies;
- 2) related purposes and instrumental to managing relationships with customers and suppliers;
- 3) functional purposes for the activity of Sweetbio Srl , including:
 - survey, direct or through third parties, the degree of satisfaction of clients and suppliers on its activity;
 - promotion and sale of the activity of Sweetbio Srl , carried out by letter, automated systems, telephone, etc .;
 - market surveys and statistical elaborations.

The personal data processed by customers and suppliers are those reported, respectively, in the contract of sale or supply, in the assignment or in another act with SWEETBIO S.R.L. (ex .: personal data such as name, place and date of birth, address of residence or domicile, tax code, etc ., contact details such as telephone, fax, e-mail, etc.), and can be integrated with those related to the events of the relationship.

Where - in relations with customers and suppliers - concrete and objective situations are created for which data of the data subject belonging to the particular categories of personal data must be processed, the related processing takes place only where this is necessary for the sale or the supply, on condition that, in any case, the conditions of lawfulness of processing foreseen by the Art. 9 of the GDPR and, in particular, that the data subject has given his explicit consent to the processing of such personal data.

To its customers and suppliers, SWEETBIO S.R.L. can carry out promotional initiatives.

For all these purposes, the processing of personal data takes place using manual, computerized and electronic tools, so as to guarantee privacy and security in environments with constantly controlled access.

E) LEGITIMATE INTERESTS PURSUED BY THE DATA CONTROLLER

The only legitimate interests pursued by the Data Controller related to the personal data processed by customers and suppliers are exclusively reflected in the lawful and objective necessity of being able to proceed with the execution of a sales contract (with the customer) or supply contract (with the supplier) of which the person concerned is a party or to take pre-contractual measures adopted at the request of the person concerned.

F) ANY RECIPIENTS OR EVENTUAL TARGET CATEGORIES OF PERSONAL DATA

- The personal data of the interested party - including, where appropriate, those belonging to the particular categories of personal data - object of processing by SWEETBIO S.R.L. they may be communicated, if necessary or objectively useful or appropriate, to the following possible recipients or any categories of recipients and their respective personnel:
 - members and authorized personnel of the Company;
 - parent companies, subsidiaries and / or affiliates;
 - private parties (e.g. associations of companies / entrepreneurs, external collaborators, consultants and professionals, including associates, law firms, banks, banking / financial services companies, debt collection, IT systems, data processing and transmission, archiving, insurance, management of operations assisted by government grants , etc.);
 - public entities (e.g.: Postel SpA, Judicial Offices, Chambers of Commerce , etc.).

Personal data of customers and suppliers being PROCESSED by SWEETBIO SRL they are not disseminated.

G) INTENTION OF THE DATA CONTROLLER TO TRANSFER PERSONAL DATA TO A THIRD COUNTRY OR TO AN INTERNATIONAL ORGANIZATION

The Data Controller does not intend to transfer personal data or customers, neither suppliers, to a third country or an international organization.

H) RETENTION PERIOD OF PERSONAL DATA OR CRITERIA USED TO DETERMINE THIS PERIOD

The maximum period of retention of personal data of customers and suppliers is ten years from the last necessity for processing, provided that specific legal provisions of a civil and / or penal and / or tax or judicial authority do not allow and suggest or, respectively, do not provide or impose a different retention period.

I) RIGHTS OF THE INTERESTED PARTY

The interested party has the right :

- to ask the Data Controller to access personal data and to rectify or cancel them or limit their processing or to oppose their processing, in addition to the right to data portability (Article 13, paragraph 2, letter b) of the GDPR);
- to withdraw consent at any time without prejudice to the lawfulness of the treatment based on the consent given prior to the revocation (Article 13 (2) (c) of the GDPR);
- to file a complaint to a supervisory authority: www.garanteprivacy.it (Article 13 (2) (d) of the GDPR).

J) COMMUNICATION OF PERSONAL DATA: LEGAL/CONTRACTUAL OBLIGATION OR REQUIREMENT REQUIRED FOR THE CONCLUSION OF A CONTRACT; OBLIGATION OR NOT OF THE INTERESTED PARTY TO PROVIDE PERSONAL DATA AND POSSIBLE CONSEQUENCES OF THE FAILURE TO COMMUNICATE SUCH DATA

In general terms, the communication of personal data may be necessary to fulfill an obligation under the law, a regulation or the Community legislation, or it may be a necessary requirement for the completion of a contract of which the data subject is a part, of pre-contractual measures or specific requests of the interested party.

Specifically, and for similar reasons, so that SWEETBIO S.R.L. may execute a contract of sale (with the customer) or supply contract (with the supplier) of which the interested party is a part or to execute pre-contractual measures adopted at the request of the same, the communication of personal data, including - only where appropriate - those belonging to the particular categories of personal data, it is mandatory; the failure to communicate such data prevents the execution of a sales contract (with the customer) or supply contract (with the supplier) of which the interested party is a part or the execution of pre-contractual measures adopted at the request of the same.

On the other hand, the communication of personal data is optional for processing connected to the functional purposes of SWEETBIO S.R.L., as per paragraph D), point 3), of this form; the non-communication of such data does not prevent the execution of a sales contract (with the customer) or supply contract (with the supplier) of which the interested party is a member, nor the execution of pre-contractual measures adopted at the request of the same.

K) EXISTENCE OF AN AUTOMATED DECISION MAKING PROCESS

SWEETBIO S.R.L. does not adopt any automated decision-making process, including 'profiling', that is, any form of automated processing of personal data consisting of the use of such personal data to evaluate certain personal aspects relating to a natural person, in particular to analyze or predict aspects concerning professional performance, economic situation, health, personal preferences, interests, reliability, behavior, location or movement of that physical person.

OBLIGATORY CONSENT - The person concerned, i.e. the natural person to whom the personal data refers: individual entrepreneur, trader, craftsman, professional, consumer, etc., or who acts in the name and on behalf of legal persons as their director, attorney, manager, partner, auditor, guarantor, etc., in his capacity - depending on the case - of customer or supplier, declares to have received from SWEETBIO SRL this form - also available on our website www.sweetbio.it - containing the information required by Articles 12 and 13 of the General Regulation on Data Protection (EU) 2016/679, in a concise, transparent, intelligible form and with a simple and clear language ; the interested party therefore expresses his free, specific, informed and unequivocal consent, as defined by the Art. 4 and provided for by Art. 7 of the General Regulation on Data Protection (EU) 2016/679, to the lawful processing of personal data concerning him, including - if necessary for the sale or supply - those belonging to the particular categories of personal data; the interested party also expresses his consent to the communication, if necessary or objectively useful or appropriate, by SWEETBIO S.R.L. of personal data concerning him/her, including - if necessary for the sale or supply - those belonging to the particular categories of personal data, to any recipients or any categories of recipients, and their respective personnel, referred to in paragraph F) of this form, and the related processing of the data itself, including - if necessary for the sale or supply - those belonging to the particular categories of personal data.
